- To approve the city to hire 2 crossing guards for RRSD 6-week Summer Program starting June 29<sup>th</sup> through August 7<sup>th</sup>, 2026 from Monday – Thursday at a rate of \$16.00 per hour. The crossing guards will be managed by the Police Department.
- To approve the utilization of the enclosed form entitled River Rouge City Boards & Commission Application. This form will be retained by the Clerk's office and provided to persons interested in participating on a Board or Commission.
- To approve the enclosed 2026 DWSRF Lead Service Replacement Program Construction Services Proposal from Hennessy Engineers, Inc. for contract administration and construction management for an amount not to exceed \$357,446.81.
- To approve the enclosed 2026 DWSRF Water Projects Proposal for Design, Specifications, and Bidding Services from Hennessy Engineers, Inc. for a total cost of \$229,787.24.
- To accept the enclosed recommendation by Hennessy Engineers, Inc. and tentatively award Contract 1 to All Seasons Underground of Tipton, Michigan, for the 2026 River Rouge Lead Service Line Replacements in the amount of \$1,908,251.22, which includes a 6% contingency. Award of this project would become final upon the closing of the DWRF loan in August 2026.
- To accept the enclosed recommendation by Hennessy Engineers, Inc. and tentatively award Contract 2 to Murphy Pipeline of Canton, Michigan, for the 2026 River Rouge Lead Service Line Replacements in the amount of \$2,352,800.69, this includes a 6% contingency. Award of this project would become final upon the closing of the DWRF loan in August 2026.
